Each European country has its own accreditation body, responsible for accreditation in accordance with international standards from the ISO 17000 series.

ACCREDIA is the sole national accreditation body in Italy, designated by the Government on December 22, 2009. It was formed from the merger of SINAL and SINCERT, with the contribution of SIT - INRIM, ENEA, and ISS, as a non-profit recognized association.

ACCREDIA evaluates the technical competence and professional suitability of conformity assessment operators (laboratories and bodies), ensuring their compliance with mandatory rules and voluntary standards, thus guaranteeing the credibility of certifications, inspections, tests, and calibrations.

Accreditation is important because it certifies the quality level of the work carried out by a certification, inspection, or laboratory body (for testing and calibration), verifying compliance with management system standards, competencies, internationally recognized regulations, and mandatory legislative requirements. It ensures that test reports, inspections, and certifications bearing the ACCREDIA mark are issued in compliance with the highest international requirements for conformity assessment, supported by stringent controls over operators.

In the case of laboratories, accreditation demonstrates that the organization meets the technical and management system requirements necessary to provide accurate and technically valid data and results in testing, analysis, and calibration activities.

Accreditation ensures:

- **Impartiality:** Representation of all interested parties within the body/laboratory.
- **Independence:** Absence of conflicts of interest between auditors and the certified organization.
- **Competence:** Confirmation that the personnel conducting the verification is culturally, technically, and professionally qualified.
- **Integrity:** European standards prohibit the provision of consulting services, either directly or through affiliated companies.
